Survey Objectives:

The primary goal of the survey was to gather and report indicators of the needs, desires and perceptions of Iowa Great River Road National Scenic Byway travelers and area residents. The survey's findings can assist the Iowa Mississippi River Parkway Commission (IA MRPC) and its stakeholder organizations in providing information, services and facilities that is more effective for people to experience the Iowa Great River Road National Scenic Byway. The 2013 Iowa Great River Road Survey is part of the overall updating of the Corridor Management Plan for the National Scenic Byway.

Survey Objectives:

- 1. Determine the current level of awareness of the Iowa Great River Road.
- 2. Determine whether the overall perceptions of the Byway are positive, neutral, or negative.
- 3. Recognize the degree to which visitors' trip expectations were or were not fulfilled.
- 4. Determine what qualities and/or amenities bring visitors to Iowa Great River Road counties.
- 5. Determine what community qualities or amenities residents value and how they feel the lowa Great River Road impacts those qualities and amenities.
- 6. Collect information about the types of traveler/visitor service improvements that could be implemented along the Iowa Great River Road.
- 7. Collect demographic information about travelers to and residents of the region.
- 8. Identify the frequency of travel to the area, what else visitors do with their leisure time.
- 9. Collect information about spending patterns.
- 10. Develop a survey instrument and methodology that can be replicated in the future to measure changes in a variety of key indicators including visitor/resident needs, values, and perceptions of the Iowa Great River Road National Scenic Byway.
- 11. Provide visitor and user satisfaction indicators which may be useful to other state segments of the Great River Road National Scenic Byway.

Methodology:

The 2013 lowa Great River Road Survey involved surveying two self-identified groups: visitors and residents. Visitors generally identified themselves as being on a trip more than 30 miles from home. Residents generally identified themselves as a resident of the county from the where the survey request was made. Visitor and resident survey forms are included at the end of this report.

From June to October 2013, a survey representative approached individuals who were visiting selected locations or participating in selected events in the 10 counties of the lowa Great River Road. The representative identified herself, her role with the survey project and asked if the individuals would answer a few questions. If the party agreed to complete a self-administered questionnaire, she provided three options for completing the appropriate visitor or resident survey:

- completion on the spot;
- completion later with a mail-in return; or
- on-line completion using SurveyMonkey.com.

All prospective survey respondents were offered the opportunity to enter a sweepstakes drawing for a \$100 Visa gift card--an expression of appreciation. The sweepstakes drawing

was conducted independent of the survey process. The identity of all survey and sweepstakes respondents is confidential and not reported.

Overall, approximately 817 visitor surveys were distributed and 430 returned. 834 resident surveys were distributed and 428 returned.

INDIVIDUAL RESPONDENT COMMENTS

More boat ramps have been added and fixed up

Sediment now fills in much of the Mississippi backwaters a change for the worse, however, I have read the Mississippi is clearing up from pollution problems.

Increase in population thus more usage of resources

very busy tourist area....less people seem to frequent town but look for places to "stay"....river is busy and lots of biking but the "trail" along the highway isn't what most consider adequate bike trail. Traffic and wide loads can make some areas dangerous

Buildings in disrepair, swimming pool outdated

Many homes and buildings have been neglected or updated in a haphazard manor. I suspect lack of interest or \$\$ or both.

Enhanced downtown area to include upgraded buildings, additional and broadened dining and shopping options and improved beaches on river sand bars. The complexion of the local population has grown to individuals with varied and interesting backgrounds and life experiences.

We are seeing the positive effect being a "Main Street Iowa" is having on the community and the face of Lansing's downtown.

The school is getting better. Town in developing more.

More activity & vitality in town; more recreational opportunities.

It has changed, but the changes have been both for the better and worse. Example: more people, both travelers and residents--good for economy, not always good for the environment.

Better stores to shop in. Better docking for boats. Parks updated. Roads updated. Scenic viewing spots of the river. Better care of the river. Residents taking better care of their property.

The area has simply become more beautiful as a result of increased community involvement and projects.

I think there have been some good improvements made, but while thinking back I'm not sure those changes were for the better or for the worse. I think it was more to "maintain"

Would like to see more scenic overlooks, brush and trees removed from the line of scenery while driving along the GRR especially going North from Marquette, IA and from Lansing to New Albin. Needs an information and tourist center somewhere. Needs a newly paved road between Hwy 76 and Harpers Ferry. Appears to be coming with the new bike path on the GRR. Local business needs to promote the GRR more and that they are part of a National Scenic By-Way. Harpers Ferry needs a visitor's center with information available. The street coming into Lansing between the Lansing Harpers Road and the road to get onto the Black Hawk Bridge is very rough and needs widening and resurfacing. DNR parks and waysides are poorly maintained but County Conservation parks and way sides look very nice. Thank you County Conservation. More history needs to be revealed in Allamakee County.



I think the guality of the road has improved, but I feel that it would bring more people through the lowa side of the river if the river road was a state road. If you look at most road atlas', you'll see on the Wisconsin side that river road goes the length. In Iowa, it seems like part of the road are missing, such as the stretch from Lansing to Harper's Ferry. The reason is that is a county blacktop so it doesn't show on many of the atlases. People not knowing that the road continues from New Albin to Marguette would choose the Wisconsin side because the road is continuous over that same area. The idea that the state has turned over the stretch from Harper's Ferry to Hwy 76 and wants to do the same with the piece of Hwy 26 between New Albin and Lansing, will only make that look less attractive to people traveling through the area. I also think some promotion of areas like Blackhawk next to the Upper Iowa River and its historic significance as they do on the Wisconsin side would be a good idea as well. As far as adding the bike lanes on Hwy 26, I don't see any return on that investment. The bicyclers don't pay any licenses on bicycles, they don't spend money in the area, and they just want water and a restroom to use and are seldom in the bike lanes anyway. I don't really understand how they are catered to so much and contribute so little in terms of the economy. Every other vehicle has to be licensed and in the case of snowmobiles and 4-wheelers, they can't even go into parks or on the road, yet we add lanes at great expense for bicycles that are primarily not paying any fees that contribute to the resources they are taking nor do they tend to spend money locally. I'm confused by this. Overall the state seems to let things be, which I think really is the best policy. I have had heard some complain that Des Moines forgets about Allamakee County. I say that might be the best thing. I don't mean that in a negative way, just that a lot of us like being in an out of the way, noncommercialized place.

The river has gotten very dirty, this is by pollution and garbage left by people "enjoying" the river. Also, most towns have become run-down in appearance and vacant.

There is noticeable improvement on homes, cabins, and general upkeep along the river areas.

Still a beautiful area to road trip on. Very scenic.

I've only lived in Allamakee County for 3 years.
