THE STANDARD SPECIFICATIONS, SERIES 2012, ARE AMENDED BY THE FOLLOWING MODIFICATIONS AND ADDITIONS. THESE ARE SPECIAL PROVISIONS AND THEY SHALL PREVAIL OVER THOSE PUBLISHED IN THE STANDARD SPECIFICATIONS.

PART 1 - GENERAL

1.1 DESCRIPTION OF WORK

- A. This work includes all labor, materials, tools, equipment, transportation, protection, and supervision necessary and required to furnish and install the site furnishings as specified in the contract documents.
- B. In order to provide uniformity in the aesthetics and style, the benches, bike rack and trash receptacle shall be obtained from the same supplier, and shall be of the style specified.

1.2 COORDINATION

- A. Contractor shall be responsible for coordinating work under this section with other trades and disciplines impacting this work, including the contractor installing the bench and bike rack concrete pads.

1.3 QUALITY ASSURANCE

- A. All of the site furnishings shall be obtained from one of the following suppliers:

1.4 SUBMITTALS

- A. Product Information:
 1. Cut Sheet and Item numbers for benches, bike rack and trash receptacle for verification to specifications prior to ordering.
- B. Warranty
 1. Provide manufacturer's standard warranty.

1.5 DELIVERY, STORAGE, AND HANDLING

- A. Deliver packaged materials in original, unopened packages.
- B. Protect from damage prior to and during installation.
 1. Damage, including scratches, chips, dents will be cause for rejection and replacement, all at no additional cost to Contracting Authority.

1.6 FIELD CONDITIONS

- A. Verify that concrete pads are constructed to the required dimensions and grades and are ready for installation of site furniture.

PART 2 - PRODUCTS

2.1 SITE FURNITURE

- A. Provide the following site furniture sets from one of the following three suppliers:
 1. Victor Stanley
 - a. Trash Receptacle: RB-36, Steelsites RB Series 36 Gallon, with plastic liner and S-2A Dome Lid; black powder coated finish; surface mount
 - b. 6 foot Bench: CR-196, Classic Series Contoured Bench, 6 foot Scrolled Vertical Steel Slats
 - c. Bike Rack: BRCS-103, Cycle Sentry Series 3 Loop Bike Rack; black powder coated finish; surface mount
 2. BRP by Bison

- a. Trash Receptacle: MC 404-DT-SM, 32 Gallon litter receptacle, with dome top; Raven powder coated finish; surface mount
 - b. 6 foot Bench: MC 104-72, Manchester Bench with back, decorative cast ends, 6 foot; Raven powder coated finish; surface mount
 - c. Bike Rack: BWA2-05-SM, Wave[™] Bike security station, five bike capacity; Raven powder coated finish; surface mount
3. DuMor, Inc.
- a. Trash Receptacle: 84-32FTO receptacle with bonnet lid; black powder coated finish; surface mount
 - b. 6 foot Bench: 58-60; black powder coated finish; surface mount
 - c. Bike Rack: 130-20 loop; black powder coated finish; surface mount

PART 3 - EXECUTION

3.1 EXAMINATION

- A. Examine areas where site furnishings are to be mounted, with Installer present, for compliance with requirements and conditions affecting installation and performance of the Work.

3.2 INSTALLATION

- A. Install site furnishings in accordance with suppliers written recommendations.

PART 4 - METHOD OF MEASUREMENT

4.1 MEASUREMENT

- A. Method of Measurement: The Engineer will count EACH installed SITE FURNISHINGS: BENCH, METAL, 6 foot; SITE FURNISHINGS: TRASH RECEPTACLE, METAL; and each SITE FURNISHINGS: BIEK RACK, METAL that is in conformance with the project documents.

PART 5 - BASIS OF PAYMENT

5.1 PAYMENT

- A. Basis of Payment: Payment will be at the contract unit price bid for each SITE FURNISHINGS: BENCH, METAL, 6 foot; SITE FURNISHINGS: TRASH RECEPTACLE, METAL; and each SITE FURNISHINGS: BIKE RACK, METAL, according to the contract documents. This payment shall be full compensation for all transportation, materials, tools, equipment, supervision and labor to furnish and install the site furniture in accordance with the contract documents. Payment includes manufacturer's standard warranty.
