THE STANDARD SPECIFICATIONS, SERIES 2015, ARE AMENDED BY THE FOLLOWING MODIFICATIONS AND ADDITIONS. THESE ARE SPECIAL PROVISIONS AND THEY SHALL PREVAIL OVER THOSE PUBLISHED IN THE STANDARD SPECIFICATIONS.

151127.01 DESCRIPTION.

- A.** There are no requirements restricting the potential bidders on this contract. Article 1102.01 of the Standard Specifications shall not apply. All contractors who are not suspended, debarred or otherwise ineligible will be authorized to bid upon following the request procedures in Article 151127.02.
- B.** Following the bid opening, the Contracting Authority may make inquiries of the lowest responsive bidder regarding the bidder's experience, number of employees, and ability to finance the cost of the public improvement in order to determine if the lowest responsive bidder is a responsible bidder.

151127.02 BIDDER ELIGIBILITY.

- A.** All potential bidders who are not already prequalified by the Iowa DOT will be required to submit the information requested in Attachment A in order to be eligible to bid on this contract.
- B.** In addition to the company information above, a Bidder Status Form (Attachment B) and a Submission of Electronic Bids form (Attachment C) must be completed and submitted with your request.
- C.** Upon receiving these forms, the Department will instruct potential bidders on additional procedures required to bid the contract, including obtaining a bidding ID and requesting a proposal.

151127.03 BIDDER RESPONSIBILITY.

- A.** Following the bid opening, the Contracting Authority may require the lowest responsive bidder to

submit the form in Attachment D to determine if this bidder is a responsible bidder.

- B.** If the Contracting Authority determines this bidder is not in fact a responsible bidder, the next lowest bidder may be required to submit the form in Attachment D to determine if they are a responsible bidder.
- C.** This procedure will continue until a bidder is awarded the contract or all responsive bidders have been rejected.

Submission of Electronic Bids

The Iowa Department of Transportation requires contractors to submit bids electronically for work being bid through the Iowa DOT. These procedures are in compliance with Iowa Code 554D.

This form must be signed by an officer of the company and shall be submitted to the Iowa DOT **prior to** the letting for which the contractor would like to submit bids electronically.

By signing below the contractor agrees:

1. They will not submit an electronic bid for a contract unless they have been approved as a valid bidder for that proposal.
2. They will submit an approved electronic bid bond with the bid, or furnish an individual proposal guaranty to the Iowa DOT if required prior to the deadline for bid submittal.
3. They will prepare and submit their bid with the AASHTOWare Project Bids software that the Iowa DOT is currently using.
4. They understand the bids will be electronically submitted to Info Tech Inc., of Gainesville, Florida, as an independent depository for the electronic bid submission, and that the Iowa DOT will not have access to these bids until after the deadline for bid submittals.
5. They will secure BidExpress account from Info Tech Inc. to access www.bidx.com and submit their bids.
6. They will furnish to the Iowa DOT the names of individuals who are authorized to sign bids electronically for the company.
7. They will notify the Iowa DOT if an individual who is authorized to sign should be removed from the list of individuals who are approved to sign bids electronically for the company.
8. They will obtain a separate "Private Key" for each individual who will be authorized to submit an electronic bid to the Iowa DOT.
9. They will ensure the confidentiality of the "Private Key" for the individuals who have obtained them for the contractor.
10. They agree that the submission of a digitally signed electronic bid constitutes the signature of the electronic bid.
11. They agree that the submission of a digitally signed electronic bid also certifies acceptance of the bidder's Acknowledgements and Certifications included in the electronic bidding file.
12. They agree that the end of the transmission of the electronic bid from the contractor to Info Tech Inc. will be considered as the time the electronic bid was submitted.
